World Cup 2010 Terms & Conditions

The 32 nations in the 2010 FIFA World Cup have been announced, however the draw on December 4th, 2009 will determine the first round match locations and dates for all thirty two nations. In order to secure your place as part of the tour, you must review the terms & conditions and complete the **booking form** and return to SITA World Tours, along with your applicable deposit or full payment. We encourage you to purchase travel insurance to protect your investment.

Deposit: A non-refundable deposit of 50% per person is due at the time of booking along with the correctly completed Booking Form. All payments are accepted on first come, first serve basis subject to availability. Your deposit is your confirmation that we may proceed with securing accommodations as requested.

Payment schedule:

A 2nd payment of an additional 25% is due by December 1st, 2010. Final payment is due by February 15th, 2010.

Transfers: Options for match day transfers will be provided after the draw on December 4, 2009.

Airport transfers are included in the package price when you purchase your international flights in connection with the match packages from SITA World Tours.

Accommodations: The accommodations used in these packages are based on the room share requested. Selected for their ambience, facilities, location, distance from stadiums and airport. Hotels vary from property to property. The company reserves the right to substitute any hotel at any time for another property consistent with the category. Regardless of your arrival or departure times for the hotel, early check-in or late check-out cannot be offered.

Ground Transportation in South Africa is only included when specifically mentioned in the package inclusions. We reserve the right to determine the mode of transportation on any service included in the package price. This may include coaches, mini vans, trains, and other modes.

Event Tickets: Team specific match dates and venue are to be determined by FIFA on December 4th, 2009. No team will play twice in the same stadium for the first round.

Household Limits: Clients can only request up to four (4) 2010 World Cup tickets for up to seven (7) matches per household. Clients are not allowed more than one single Match on the same Match day or Multiple Ticket Applications for the same Match that have been submitted through the various Ticket sales channels.

Extra Nights and Additional Match Tickets can be purchased after the draw on December 4th, 2009.

Package prices are subject to change at any time as supply and demand dictates. Family package rates will vary. The maximum number of guests per room is four, with a maximum of two beds. World Cup ticket prices cannot be discounted regardless of age.

Prices: All prices are per person and are based on USD. SITA World Tours reserves the right to increase prices based on international currency fluctuations or increases in airfare cost. This stipulation is in effect until full payment of the package has been received by us. Prices may fluctuate based on dates of travel and matches selected.

Airport taxes: (Departure, Arrival, Security and government taxes etc.) These are not included in the tour cost as they are continually changing i.e. Due to exchange rate fluctuations, adding and deleting of taxes etc. Taxes will be advised and payable at the time of final payment.

Airfares: These are not included in the tour cost as they are continually changing and subject to space available. Any airfare is not guaranteed until booked & ticketed.

Insurance is highly recommended. You can protect yourself against cancellation penalties if you cancel for a reason covered by the insurance policy you choose. All insurance policies are different. Please read all insurance policy documents to be sure you fully understand them.
